- Cut concrete floor to the required dimensions for the insert of stainless steel.
- The signage must be level to the concrete.
- Size: 1000mm X 600mm

STEEL WORKS:

- The contractor must supply and fit all required materials listed below.
- 0.9mm stainless steel plate to be laser cut to the required shape, samples will be handed in the site visitation.
- All edges must be beveled.
- The stainless steel plate must be high machine polished.

FIXTURES:

- All fixtures must be stainless steel.
- Fixtures must be recessed to the same level of the floor.
